Well, it's an open source project, so here's my first contribution:

I've added a decoder file for the Lenz LE077XF decoder (their smallest, a great "fleet" decoder for N scale) and updated the MultiPane file to display the CVs in the appropriate panes. To use these files, add the decoder file to the directory

"DecoderPro0.9b3/xml/decoders",

and replace the "MultiPane.xml" in the directory

"DecoderPro0.9b3/xml/programmers"

with the one here. It is necessary to have both files in place to get the full functioning of the decoder file.
